





JUMP-X CORD BREAKDOWN





PRODUCT SETUP DETAILS



ATTACHING THE SET OF JUMP-X CORDS TO TRAK-X

STEP 1

Clip in the CLIP-X ends of the JUMP-X Cords into each side of the PERFORM-X Platforms inlaid TRAK-X using screw heads/holes in inlaid Trak-X as reference.


- STEP 2

Make sure the CLIP-X clips for both cords are directly across from each other (using screw heads in TRAK-X holes in inlaid TRAK-X as reference).

FASTENING BELT-X

STFP 1

Hold BELT-X in left hand holding Female Attachment End.



PULL TO ADJUST BELT SIZE ALWAYS AVOID SLACK & KEEP EVEN

STEP 2


With your right hand, pull Male Attachment End as needed to make sure Doubled Up Adjustable Strap feeds EVENLY through that end.


STEP 3 —

With D Rings on BELT-X facing down toward the ground, put BELT-X around waist and clip ends together.

Adjust as needed by lifting and pulling Male Attachment End. Make sure Doubled Up Adjustable Strap still stays even.


Tighten BELT-X by EVENLY pulling Doubled Up Adjustable Strap.





STEP 4

IMPORTANT STEP – When tight, pull Doubled
Up Adjustable Strap aggressively upwards and
back behind buckle to bind up loose end behind
buckle. Then tuck that end to the left of buckle
for maximum hold.



ATTACHING JUMP-X CORDS TO BELT-X

STEP 1

With BELT-X on, kneel down between JUMP-X Cords.

STEP 2

Take JUMP-X Cord by carabiner and clip to D ring on that side of BELT-X. Do the same on the other side with other JUMP-X Cord.



STEP 3


Stand to start drills.

NOTE: For shorter users and to start with more resistance, use same steps as above but before standing clip carabiner into lower D ring on JUMP-X Cord on both sides.

ADJUSTING JUMP-X CORDS USING D-RING

STEP 1

While kneeling, insert adjustable D-ring into caribiner for additional resistance.


NOTE: D-ring also provides proper resistance for shorter users.
