


* See reverse side for CLIP-X anchoring instructions ** Cord only works with TRAK-X





SCAN FOR SETUP + USE

PRODUCT SETUP DETAILS

Lay out POWER-X cords in line with platform inlaid TRAK-X (one cord on each side of platform next to TRAK-X). Make sure Cam Buckle and Cam Tether are centered on platform on each side with each POWER-X Cord.

Clip one end of the POWER-X Cord into TRAK-X. Pull opposite end taut and clip into TRAK-X. Repeat with second POWER-X cord making sure to line up CLIP-X with first cord CLIP-X locations.






• STEP 3 - Attach Cam Buckle to bar on each side.
